Submissions

The conference welcomes papers in all areas of economics. The deadline for submissions is June 30, 2009. The submitters will be notified about the status of their submissions by July 20, 2009.

Papers can only be submitted electronically through the Scholarly Web-portal that can be reached from the ASSET 2009 website. Submissions will not be accepted in any other form. Co-authored papers should be submitted by the author who intends to present the paper with at most one submission per person.

ASSET awards Louis-André Gerard-Varet prizes to young authors (either currently graduate students or within 2 years of graduating at the time of the conference) of outstanding papers singled out by the Programme Committee among those attending the ASSET conference. In the case of co-authored papers, all authors must be individually eligible.
