CEIS - University of Rome "Tor Vergata" June 26th-28th 2002 Call for papers The 14th Mondragone International Economic Seminar, organized by CEIS (Center for International Studies on Economic Growth), University of Rome "Tor Vergata", will be held on June 25-27, 2002. The aim of the Seminar is to investigate the role that institutions play in the growth process and to analyze the problem of designing, for the European Union, institutions that will be able to foster economic growth and, at the same time, meet the challenges of enlargement and further integration. The Seminar will be made of two main parts. The first part is to review and provide new contributions, from a theoretical, empirical and historical point of view, on the effects that political, legal and regulatory institutions have on economic development. The second part is to provide some ideas and evidence for the debate which is undergoing at the European level on the economic strategies for the future, on the design of new decisional processes and on the allocation of new policy prerogatives at the union level.
