EEFS2008 European Economics and Finance Society Call for papers The Seventh Annual EEFS Conference, will be held in Prague, Czech Republic on 22nd - 25th May 2008 hosted by the University of Economics in Prague The theme of the Conference will be: "Globalised Labour & Capital Markets, National Resources and Shifts in Economic Power" The Conference will focus on changes in the global economy and the European Integration process. Papers are solicited in areas such as: - Labour Economics - International Trade and General Equilibrium - Analysis of Financial Markets - Macroeconomic Issues and Policy - Growth and Development - Factor Mobility - European Integration - International Monetary Economics - Economics of Transition - World Integration - Economic Geography - Spatial Economics - Regional Economics and Policy - Industrial Economics and Organisation - New Political Economy - Public Economics Paper Submission Abstracts of papers and/or session proposals should be submitted electronically by January 15th, 2008 to the scientific committee of the conference as attachments (doc or pdf format) at the following email address: eefs@eap.gr Abstracts of no more than 200 words should contain JEL classification codes. The authors" full name, affiliation, address, phone/fax, and e-mail for correspondence should also be indicated. An entire paper may be submitted, when available, but it must include an abstract. Paper acceptances will be sent by February 20th. The deadline for the payment of the conference fee of € 210 will be 20th March 2008. Authors whose papers are selected for the conference should send an electronic copy of the final version of their paper by April 15th 2008 in order to upload their paper on the conference website in a timely manner. Papers should not exceed a maximum of 20 pages. Conference Website The conference web address is at http://eefs2008.vse.cz/ where you will find information regarding the Conference Programme, recommended accommodation, maps/instructions, registration forms and other useful information. Conference Fee The Conference fee is € 210 and should be paid by March 20th 2008. It covers access to all sessions, a welcome reception on the evening of 22nd May, lunch and dinner for two days, conference breaks and conference material. Conference fees will not cover the participation in the voluntary excursion planned on 25th May, charged at an additional €70. The conference fee for research students is €150 (a covering letter of proof of research student status is required either from your supervisor or the head of your department). Late payments: After March 20th the conference fee will be €260. The fee for accompanying persons, which includes a welcome reception on the evening of 22nd May, lunch and dinner for two days, is €70 per person.
